AN ADDRESS ON PERSONAL PRIVACY * DELIVERED TO THE LOS ANGELES LAWYERS FOR HUMAN RIGHTS by THOMAS F. COLEMAN, Esq. February 25, 1982

"Personal Privacy" is a context, indeed the only context, in which certain fundamental human values such as liberty or the pursuit of happiness, can exist and flourish. Privacy is the ground of being for such values as free will or freedom of choice.

In order for an individual to maintain the integrity of his personality, his claim of privacy must be acknowledged by society. Likewise, a true experience of respect, love, friendship, and trust in one's relationships requires a context or atmosphere of privacy.

In the first appellate decision recognizing the right of privacy as rooted in state and federal constitutional provisions which declare that "no person shall be deprived of liberty except by due process of law," Georgia Supreme Court Justice Cobb wrote in 1905, "The right of privacy has its foundation in the instincts of nature. It is recognized intuitively, consciousness being the witness that can be called to establish its existence. Any person whose intellect is in a normal condition recognizes at once that as to each individual member of society there are matters private, and there are matters public so far as the individual is concerned. Each individual, as instinctively resents any encroachment by the public upon his rights which are of a private nature as he does the withdrawl of those of his rights which are of a public nature. A right of privacy in matters purely private is therefore derived from natural law."

In the simplest of terms, the right of privacy has been called "the right to be let alone." It has been regarded as the most comprehensive of rights and the right most valued by civilized men.

There appear to be three major areas of privacy for which individuals have the most concern: territorial privacy, decisional privacy, and informational privacy. Sometimes stemming from his natural instincts, and othertimes from his interest in maintaining human dignity, territorial privacy rights are claimed. The most obvious territorial claim pertains to one's home. Other claims stem from man's desire for physical solitude and security in places outside of the home. This aspect of personal privacy arises from the right to be free from physical intrusion and surveillance under circumstances rendering the claim to be reasonable. These privacy claims often receive protection from the Fourth Amendment to the United States Constitution. However, the United States Supreme Court has stated that "the Fourth Amendment cannot be translated into a general constitutional 'right to privacy.' "Search and Seizure provisions of the California Constitution also protects such territorial claims as an aspect of "personal privacy" when the individual's expectation of privacy is reasonable under the circumstances.

The second major aspect of personal privacy has been called "decisional privacy" because it "includes the privacy in independently making certain kinds of important decisions." The "autonomous control over the development and expression of one's intellect, interests, tastes, and personality" are among those precious rights protected by personal privacy. This right has been given some extension to decisions and activities relating to marriage, procreation, contraception, family relationships, child rearing, and education. One's sexual orientation would receive protection from unreasonable discrimination under this aspect of personal privacy.

The third major aspect of personal privacy can be labelled "informatonal privacy." Data collection, maintenance, and dissemination are associated with this dimension of privacy. Unreasonable interrogation or investigation, data security and confidentiality, and unjustified disclosures of personal information are often major problems. The United States Constitution may afford a degree of protection to the individual against unreasonable governmental practices in this area, but the United States Supreme Court has yet to tackle this issue in any significant manner. Unreasonable information practices by private enterprises or persons is not curtailed by the Federal Constitution, although there are a few federal statutes on this subject.

Californians are becoming increasingly concerned about personal privacy. Hence, ten years ago, California voters included "Privacy" as a fundamental right in our State Constitution. The primary objective of this amendment was to afford protection to individuals against unreasonable informational practices of government agencies and private businesses. This constitutional amendment reflects "the public policy favoring protection of privacy rights." More recently, the People, through their elected representatives, enacted "Consenting Adults" legislation as well as laws affording privacy protection in the areas of insurance, medical, employment and other records. Also, the recent Briggs Initiative or so-called "homosexual teachers initiative", was firmly rejected by the voters and most policy makers, primarily for privacy reasons.

As citizens, voters, and residents of Calfornia and the nation become more "privacy conscious," there is an increasing need for continuing research and education of policy makers, professionals, and the public regarding pressing personal privacy problems and reasonable solutions to them. The Commission on Personal Privacy is a giant move in this direction.


Domestic Partnerships and the Changing Family to Headline September Meeting

The changing family is an issue of importance, not only to couples, but to single persons as well. The American Family depicted in "Ozzie and Harriet" and "Leave It To Beaver" 30 years ago is today only a figment of Ronald Reagan's receding recollection.

Fewer than one in ten families consist of the traditional model of breadwinner father, homemaker mother and two or more children. Today's families include domestic partnerships, either hetero or homosexual, extended families and single persons.

The feature speaker at SDDC's September 28th meeting will be Thomas F. Coleman, a Los Angeles attorney who is a member of the California State Task Force on the changing family which was established in 1987 by the state legislature to make recommendations on social, economic and demographic trends. He will share the platform with Jean Harris, executive assistant to San Francisco's President of the Board of Supervisors Harry Britt. Britt was the principal author and promoter of the currently stalled "Domestic Partner Ordinance" in San Francisco.

California has a history of flexibility in defining "family." The California Supreme Court wrote in 1921 and reaffirmed a few years ago, "Family may mean different things under different circumstances. The family, for instance, may be a group of people related by blood or marriage, or not related at all, who are



living together in the intimate and mutual interdependence of a single home or household." A recent Los Angeles study showed that 31% of households there consist of a single person living alone.

President's Message

Neil Good is mised. There is no doubt that the gay and lesbian community of San Diego has lost a leader of stature. The editorial from the San Diego Tribune, reprinted here, makes the case that the loss is felt throughout the city.

Much has been written about the loss. As I reflect on Neil's life, I am struck by his legacy to all of us. Many in our community came to know him during his race for city council in 1987, but the political movers and shakers of San Diego already knew Neil Good.

Neil had marched in the fields with Chavez in the early 70's. He had been the chair of the San Diego Democratic Central Committee. He had been a top assistant to local office-holders. Neil had done all of this before he ran for city council. During his years of activism as a Democrat, he was also going through that process we know as "coming out" to himself and to those close to him.

Running for public office was a logical step in his political career. When he announced for City Council it was also logical to run a campaign as an openly gay man. Neil was criticized by some in the community for running as a politician and a candidate who was gay rather than putting his credentials as a gay activist first. I think those critics missed the point of Neil's unique contribution to Gay and Lesbian politics. His history was full of Democratic party activism. He was indeed a politician in the best sense of the word. He was known throughout the state as a shrewd and analytical observer of politics. When Neil added his perspective as a gay man to this experience, he gave our community another level of visibility.

Neil Good is missed. His political legacy is still with us. He left a path for others to follow. There will be future political leaders who are gay. There are some today that are not yet publicly known. These men and women will find the doors are open wider because Neil was there.

SDDC Members to Campaign for Van De Kamp

The first organizational meeting of local gay men and lesbians supporting the 1990 California gubernatorial campaign of John Van de Kamp will take place at the home of Charles McKain on Sunday, September 17 at 7:00 p.m.

Among SDDC members committed to working for Van de Kamp's election are McKain, January Riddle and Doug Case.

As California's Attorney General, John Van de Kamp has appointed gays and lesbians to major positions in his office, created the nation's first AIDS task force to protect PWA's from fraud and issued his official Attorney General's legal opinion declaring illegal discrimination against gays and lesbians. Van de Kamp opposed propositions 64, 69 and 102 and created and sponsored Assembly Bill 1952 allowing California to test AIDS drugs without FDA approval.

Married couples benefit from a wide variety of privileges ordinarily denied to single persons or unmarried couples, whether hetero- or homosexual. For example, various consumer products and service discounts, including insurance, are often available legal rights usually denied to unmarried couples.

Denial of legal rights to unmarried couples can be emotionaly and financially devastating. We're all aware of the much-publicized struggle of Karen Thompson over visitation, medical care and guardianship of her lover, Sharon Kowalski. Many of us know of cases much closer to us where the death of one lover deprived the surviving partner of all legal and material rights.

Thomas F. Coleman served as principal consultant to the Los Angeles City Task Force on Family Diversity and was the author of its final report. He is an adjunct professor at USC Law Center, where he teaches a class on "Rights of Domestic Partners." He is widely recognized as an authority on this subject, having appeared on numerous platforms as well as on radio and TV. He was a guest speaker on the subject of domestic partners on the nationally telecast program "Nightline" with Ted Koppel.

Jean Harris is a long-term political activist and is currently chair of the Lesbian and Gay Caucus of the California Democratic Party. She is active in the campaign to prevent the overturning of San Francisco's Domestic Partners Ordinance.

WHEREAS, government authority to support the family and address family issues is vested in various levels and branches of government; and


