# CERTIFICATE OF APPOINTMENT OF DEPUTY COMMISSIONER OF CIVIL MARRIAGES

**CAROLYN SKALNEK** is hereby appointed a Deputy Commissioner of Civil Marriages to solemnize a marriage in California, pursuant to the provisions of Sections 401 of the California Family Code. This commission is effective October 17, 2008 through October 19, 2008. This deputization is only for the marriage of THOMAS F COLEMAN to MICHAEL A VASQUEZ. The Deputy Commissioner of Civil Marriages acknowledges that she is appointed for the limited purpose of performing the one civil marriage referenced above. No employment relationship is created by virtue of this appointment.

By accepting this appointment, the Deputy Commissioner of Civil Marriages acknowledges that she is subject to any laws applicable during the tenure of appointment. Deputy Commissioners of Civil Marriages serve at the will of the County Clerk and Commissioner of Civil Marriages. Any injuries incurred during the private performance of marriage ceremonies will not be eligible for coverage under the County's workers compensation program. Furthermore, inasmuch as the Deputy Commissioner's performance of marriage ceremonies outside of the County Clerk's Office is not a county activity, she understands that she alone will be responsible for any injuries she might cause to third parties and agrees to indemnify and defend San Diego County and its County Clerk against any claims for injuries caused, or alleged to have been caused by her in the performance of the marriage ceremony.
